The Confederation of European Forest Owners (CEPF) is recruiting a **Junior EU Policy Officer** to support its work.

#### **Job description**

You will work within the CEPF team to contribute to policy and advocacy work. You will mainly carry out the following tasks:

- Monitor and report on the development of EU forest-related policies, including agricultural and rural development policy and policies aiming at halting deforestation
- Support in framing CEPF positions on EU-forest related policies and engaging with EU institutions
- Gather and analyse information at national level in areas of CEPF interest
- Provide support for organising CEPF events and meetings

## **Personal qualifications**

- Full professional proficiency in English. Knowledge of other languages represents an additional asset
- Good writing/editing skills in English and confidence in verbal expression
- Team player, with a positive attitude, sociable and reliable
- Ability to be self-driven and work independently
- Ability to prioritise and to meet tight deadlines
