- more than 1,200 non-state forest owners (communities, towns, private forests, forest cooperatives, unions of small-scale owners, churches) managing c. 400,000 hectares of woodlands
- more than 15 % of the total forest area in the Czech Republic
- cca 36 % of the non-state forests in the Czech Republic
